- (a) & (b) As per periodic inspection carried out by the Veterinary Council of India as provided under Section 19 of the Indian Veterinary Council Act, 1984, following Veterinary Institutions, included in the First Schedule to the Act, were found to be deficient in terms of teaching and non-teaching manpower and infrastructure facilities such as laboratory equipment, certain parameters of Teaching Veterinary Clinical Complex (TVCC) and Instructional Livestock Farm Complex (ILFC) etc.-

- (c) Veterinary Education is a state subject and setting up of Veterinary Colleges/Institutions is under the domain of State/UTs Government to meet their requirement of trained veterinary manpower as per the availability of resources. The concerned State Governments and Universities are responsible for providing basic facilities and human resources in the veterinary institutions under their control. Setting up of Central Veterinary College/Institution is under the domain of Indian Council of Agricultural Research (ICAR). ICAR provides assistance to the Agricultural Universities including Veterinary Universities to plan and coordinate agricultural education in the country through the implementation of Scheme, "Strengthening and Development of Higher Agricultural Education in India". Financial support is given mainly for students, amenities & facilities, strengthening of infrastructures, curriculum delivery, examination system, educational quality and reforms comprising accreditation, evaluation, human resource development through faculty development, faculty exchange, scholarships and personality development, etc
