Percentage of Forest Land

1799. SHRI MD. BADARUDDOZA KHAN:

Will the Minister of ENVIRONMENT, FORESTS AND CLIMATE CHANGE be pleased to state:

- (a) the percentage of land in the country under forests cover;
- (b) whether the percentage has changed during the last few years and if so, the details thereof during each of the last three years and the current year; and
- (c) whether any forest land has been acquired for any major project in public sector or private sector during the said period and if so, the details thereof, State/UT-wise?

ANSWER

MINISTER OF STATE (INDEPENDENT CHARGE) FOR ENVIRONMENT, FOREST AND CLIMATE CHANGE (SHRI PRAKASH JAVADEKAR)

- (a) As per India State of Forest Report-2015, the total forest cover in the country is 7,01,673 square kilometers which is 21.34% of the total geographical area of the country.
- (b) The Forest Survey of India has been carrying out assessment of forest cover on biennial basis since 1987 using remote sensing technology. India State of Forest Report-2015 is the latest in the series. The total forest cover and percentage thereof as per India State of Forest Reports 2011, 2013 and 2015 are given as under:-
