(b)&(c): The Employment through Skills Training & Placement (EST&P) component of Deendayal Antyodaya Yojana- National Urban Livelihoods Mission aims at providing skill training to the urban poor as per the skill demand from the market, so that they can set up self-employment ventures or secure salaried employment. A statement showing State-wise number of beneficiaries provided Skill Training and Placement under Deendayal Antyodaya Yojana- National Urban Livelihoods Mission during 2015-16 is at Annexure-II.

(d): Under the 'Self Employment Programme' Component of Deendayal Antyodaya Yojana-National Urban Livelihoods Mission, financial assistance is provided to individual/groups of urban poor for setting up gainful self-employment ventures/ micro-enterprises. The project cost ceiling is Rs. 2.00 lakh for individual enterprises and Rs. 10 lakh for group enterprises. Amount of interest over and above 7 percent rate of interest is provided as interest subsidy for setting up of an individual or group A statement showing State-wise number of beneficiaries enterprise. assisted for Self- employment under Deendayal Antyodaya Yojana- National Urban Livelihoods Mission during 2015-16 is at Annexure-III.
