- (a) & (b) The Government considers the proposals pertaining to Mass Rapid Transport Systems in urban areas only after receipt of such proposals from State/UT Government as "Urban Transport" is intertwined with Urban Development, which is a State subject. As and when the projects are received, the same are considered based on feasibility and availability of resources. The details of the metro rail projects received from various State/UT Governments during the last three years including current year are enclosed at Annexure.
