- (a) whether the Short Term CooperativeCredit Institutions (STCCI) are ensuring/making payments to a significant number of MGNREGS workers in the country;
- (b) if so, the details thereof, State/UTwiseincluding Rajasthan;
- (c) whether the administrative and other expenditure of the STCCIs in making these payments to MGNREGS workers are reimbursed by the Government; and
- (d) if so, the details thereof and if not, the reasons therefor?

(a)to(d): Only those Short Term Cooperative Credit Institutions facilitating timely wage payments which are fully on Centralized Banking System and at par with the banking facilities like commercial banks. State/UT-wise details of cooperative accounts of Mahatma Gandhi National Rural Employment Guarantee Act active numbers are given in the **Annexure**.
