- (a) whether the Government is implementing a Dairy Development Scheme in Madhya Pradesh;
- (b) if so, the details thereof;
- (c) the number of 'Dugdh Paalan Samiti' functioning in Sagar region of Madhya Pradesh; and
- (d) the efforts made by the Government to increase the number of 'Dugdh Paalan Samiti' in Sagar region of Madhya Pradesh along with the extent of success achieved in this regard?

ANSWER

THE MINISTER OF STATE FOR AGRICULTURE AND FARMERS WELFARE

(SHRI MOHANBHAI KUNDARIYA)

(a) & (b) The Department is implementing the following Dairy Development schemes in Madhya Pradesh;

i. National Dairy Plan (Phase-I):

The Government of India has approved National Dairy Plan Phase- I (NDP-I) with an outlay of Rs. 2,242 Crore for implementation during 2011-12 to 2018-19 as a Central Sector Scheme in 18 major milk producing states including Madhya Pradesh. The Scheme is implemented through National Dairy Development Board and the objectives of the National Dairy Plan, Phase I are:-

- (a) To help increase the productivity of milch animals and thereby increase milk production to meet the rapidly growing demand for milk.
- (b) To help provide rural milk producers with greater access to the organized milk-processing sector.

As on February 2016, 11 sub projects were approved with total outlay of Rs. 23.39 Cr (including Grant assistance of Rs. 21.14 Cr and EIA Contribution of Rs. 2.25Cr) for Madhya Pradesh under the scheme and an amount of Rs. 11.35 Cr was released as Grant Assistance.

ii. National Programme for Dairy Development (NPDD) under the Central Sector Scheme “National Programme for Bovine Breeding and Dairy Development”:

The new Scheme, National Programme for Dairy Development (NPDD) approved during 2013-14 with the budget provision of Rs.600 crore for implementation during 12th Plan. The objective of the scheme is to enhance productivity of milch animals and create dairy infrastructure for improved procurement, processing and marketing. As on February 2016, one project with total outlay of Rs.758.86 lakh including Rs. 583.13 lakh as central share has been approved for Madhya Pradesh and Rs.304.74 lakh has been released for implementation of the project.

iii. Dairy Entrepreneurship Development Scheme.

“Dairy Entrepreneurship Development Scheme (DEDS)” is implemented through National Bank for Agriculture and Rural Development (NABARD) across the country with an aim to generate self employment opportunities in the dairy sector, covering activities such as enhancement of milk production, procurement, preservation, transportation, processing and marketing of milk by providing back ended capital subsidy @ 25% of the project cost to the General Category (@33.33% of the project cost to SC/ST category) farmers/beneficiaries for bankable projects through NABARD subject to the norms of the scheme. The budget provision during 12th plan is Rs 1400 crore. As on January 2016, Rs. 25.22 Crore has been disbursed as a back ended capital subsidy to establish 3050 dairy unit in Madhya Pradesh.

- (c) As per the information received from Madhya Pradesh State Cooperative Dairy Federation, 516 Dairy Cooperative Societies (DCS) are functional in the Sagar region comprising of Sagar, Chhatarpur, Damoh, Panna and Tikamgarh districts.
- (d) Apart from the schemes referred to at part (a) & (b) above, the Government of India is also implementing a Special Package for Bundhelkhand Region and has sanctioned an amount of Rs. 21.30 Cr for implementation of Dairy Development Scheme in 2009-10 covering 6 districts namely Sagar, Chhatarpur, Damoh, Panna, Tikamgarh and Datia. At present, 26413 milk producers associated with 561 DCS are collecting an average of 51,842 Kg Per Day of milk under the project. The GOI has sanctioned second phase of the project with an outlay of Rs. 29.33 crore in 2012-13 and Rs8.30 Crore has been released for implementation of the project.
