#### LAND FOR SOLAR POWER PRODUCTION

#### 299. SHRI RAHUL KASWAN:

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) whether the Government has done an assessment of the available land for setting up Solar Power Production projects/units in different parts of the country, if so, the details thereof, State/UT-wise;
- whether the Government proposes to utilize the barren and non-agriculture land for the purpose, if so, the details thereof; and
- whether the Government proposes to incentivise its "strategic solar power production partners" to start production on such land, if so, the details thereof, State/UT-wise?

#### **ANSWER**

THE MINISTER OF STATE FOR POWER, COAL & NEW AND RENEWABLE ENERGY (INDEPENDENT CHARGE) (SHRI PIYUSH GOYAL)

- The National Institute of Solar Energy (NISE) which functioning under (a)&(b): Ministry of New and Renewable Energy (MNRE) has assessed the solar power potential in the country with an estimated 2% of wasteland use. The total potential has been assessed at 750 GW. The state-wise break up is given at Annexure. Land which is not fit for agriculture is considered for solar power development.
- The Government is taking up solar power projects in association with State the (c): Governments, the National Thermal Power Corporation (NTPC) and the Solar Energy Corporation of India (SECI) etc. under various Government of India schemes and to fulfill the Renewable Purchase Obligation (RPO).
