Will the Minister of HOUSING AND URBAN POVERTY ALLEVIATION be pleased to state:-

- (a) whether the Government has sanctioned 770 shelters for urban homeless under National Urban Livelihoods Mission (NULM) in various States recently;
- (b) if so, the details in this regard, State/UT-wise;
- (c) the assistance provided by the Government on each shelter under NULM; and
- (d) the further steps taken to build more shelter for urban homeless?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING & URBAN POVERTY ALLEVIATION [SHRI BABUL SUPRIYO]

(a) & (b): As per the information received from the States/UTs, as on 29.02.2016, a total of 770 shelters have been sanctioned by 20 States/UTs under the scheme namely 'Shelter for Urban Homeless (SUH)', a component of Deendayal Antyodaya Yojana - National Urban Livelihoods Mission. A statement showing the State/UT-wise details of the shelters sanctioned under SUH since its inception is at Annexure I.

- (c): It is the primary responsibility of the State Governments to provide shelter for the Urban Homeless people. In order to complement and supplement the efforts of the State/ UT Governments, the Ministry of Housing & Urban Poverty Alleviation is implementing a scheme namely 'Shelter for Urban Homeless (SUH)' as a component of Deendayal Antyodaya Yojana - National Urban Livelihoods Mission for providing permanent shelters with basic facilities to urban homeless. Under this component, Government of India provides 60% of the cost of construction/refurbishment of the shelters and 40% would be the State In case of North Eastern and Special Category States contribution. (Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim, Tripura, Jammu and Kashmir, Himachal Pradesh and Uttarakhand), this ratio will be 90:10. Central Government also provides 60% or 90% of the O & M cost as the case may be, for each shelter for the period of first 5 years of operation.
- (d): The Ministry is constantly pursuing with the States/UTs for effective implementation of the scheme and timely completion of the projects.
