- (a) Whether the Income Tax Department has published the names of 18 entities who owe over Rs.500 crore tax to the Government and if so, the details thereof:
- (b) The steps taken by the Government to recover the pending dues from these entities:

- (d) Whether there is any proposal to publish the names all such persons, companies etc. which owe more than Rs.1 crore income tax to the government; and
- (e) If so, the details thereof and if not, the reason thereof?

# MINISTER OF STATE IN THE MINISTRY OF FINANCE: (SHRI JAYANT SINHA)

- (a) A list of Income tax defaulters who are untraceable or have no or inadequate assets
  - has been published in newspapers and on official website by the Income tax Department in December 2015. The list of names is enclosed.
- (b) All steps mandated under law have been initiated to recover the pending dues from these entities.
- (c) The quantum of outstanding dues against the said 18 entities is Rs.1,152.52 crore.
- (d) & (e) A proposal to publish names of person with irrecoverable arrears of more that Rs.1crore is under consideration as against the present, limit of Rs.5 crores.
