**Development of National Parks**

757. SHRI VIJAY KUMAR HANSDAK:

Will the Minister of ENVIRONMENT, FORESTS AND CLIMATE CHANGE be pleased to state:

- (a) whether the Government has received any proposals from various States, including Jharkhand regarding development of National Parks;
- (b) if so, the details thereof during each of last three years and the current year, State-wise;
- (c) whether the Government has allocated/released funds for the purpose; and
- (d) if so, the details thereof, State-wise and if not, the reasons therefor?

- (a)to(d) The Ministry has received proposals from various State Governments/ Union Territories including state Government of Jharkhand seeking financial assistance for development of National Parks and Wildlife Sanctuaries under the Centrally Sponsored Schemes of “Integrated Development of Wildlife Habitats” and “Project Tiger”.

The Ministry receives proposals for management of Protected Areas/Tiger Reserves through an Annual Plan of Operation which has activities listed out as per the approved Management Plan every year for funding through on-going Centrally Sponsored Schemes viz, “Integrated Development of Wildlife Habitats” and “Project Tiger”. Details of financial assistance provided to various State Governments including Jharkhand based on the proposal received under these Schemes during last three years and the current financial year is given in the **Annexure**.
