Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) whether the National Dairy Development Board (NDDB) promotes plans and organizes programmes for the development of dairy and other agriculture based allied industries under the Integrated Dairy Development Project in various States of the country including Karnataka, Uttar Pradesh, Maharashtra and Chhattisgarh;
- (b) if so, the details of such programmes organized across the country during the last three years, State-wise along with the details of the financial assistance provided by the Government to various States;
- (c) whether the Government has received any proposals regarding setting up of dairy development projects from various State Governments including Chhattisgarh;
- (d) if so, the details thereof along with the time by which the funds are likely to be released to these States; and
- (e) the various steps taken by the Government to promote the dairy development in the country?

ANSWER

THE MINISTER OF STATE FOR AGRICULTURE AND FARMERS WELFARE

(a) & (b) National Dairy Development Board is not implementing any scheme namely “Integrated Dairy Development Project”. However, Department of Animal Husbandry, Dairying & Fisheries implemented Intensive Dairy Development Programme (IDDP) till 2013-14 which has been subsumed under National Programme for Dairy Development (NPDD) component of National Programme for Bovine Breeding & Dairy Development from 2014-15. The State wise financial assistance provided by this Department during last three years under IDDP (2012-13 & 2013-14) and NPDD (2014-15) is at **Annexure-I**.

(c) & (d) Department of Animal Husbandry, Dairying & Fisheries receive proposals for setting up of dairy development projects from various State Governments including Chhattisgarh under National Programme for Dairy Development (NPDD), a component of Central Sector scheme “National Programme for Bovine Breeding & Dairy Development”. As on 31.01.2016, this Department has approved 25 new projects in 14 States with total outlay of Rs.280.70 crore during 2014-15 and 2015-16. The details of State-wise new projects sanctioned and funds released under NPDD scheme during 2014-15 and 2015-16 is at **Annexure-II**.

(e) The Department is implementing the following schemes to promote dairy development in the country.-

- i. National Dairy Plan (Phase-I)
- ii. National Programme for Bovine Breeding and Dairy Development
- iii. Dairy Entrepreneurship Development Scheme
