Will the Minister of ENVIRONMENT, FORESTS AND CLIMATE CHANGE be pleased to state:

- (a) the total number of applications received from various industries and approved for environmental clearances during the last two years and the current year, category-wise;
- (b) the average time taken for processing of such environmental clearances;
- (c) whether the Government plans to set up a single window clearance for the projects; and
- (d) if so, the timeframe by which it is likely to be implemented?

- (a) The number of applications received from various industries and environmental clearances accorded during the last two years and the current year is as follows:

| Year | Applications received | Environmental Clearance granted |
|-------------------------|-----------------------|---------------------------------|
| 2014 | 384 | 325 |
| 2015 | 610 | 714 |
| 2016 (Till April, 2016) | 151 | 202 |
| Total | 1145 | 1241 |

The category wise details are at annexure 1 & 2.

- (b) The weighted average time taken in granting environmental clearance before launching online system (4th July 2014) was approximately 600 days, which has now come down to 192 days after launch of online system for applications for environmental clearance.

The timelines prescribed in the EIA Notification, 2006 for various stages of EC are as follows:

- 30 days for prescribing the TORs;
- 45 days for public consultation;
- 60 days for appraisal by EAC/SEAC;
- 45 days for communicating the decision of the Ministry to project proponent.

- (c) & (d) In order to bring more transparency and accountability in the Environment, Forest and wildlife Clearance processes, the Ministry has rolled out a portal named as Online Submission and Monitoring of Environmental, Forest and Wildlife Clearances (A single window clearance system). This portal provides for a single interface for proponent/user agency for submitting three separate applications pertaining to Environmental, Forest and Wildlife Clearances. On-line submission of application for environment clearance was mandated w.e.f. 04.07.2014 to bring transparency in the process of environmental clearance.
