### \*60. SHRIMATI RANJEET RANJAN: SHRI RAJESH RANJAN:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) whether the Government is aware of the instances of non-isuance of certificate to trainees whose training has been completed under the Pradhan Mantri Kaushal Vikas Yojana (PMKVY);
- (b) if so, the details thereof and the reasons therefor;
- (c) the number of trainees who have/ have not been disbursed cash under PMKVY during each of the last three years and the current year;
- (d) whether the Government has any database of persons having been skilled under PMKVY getting employ after completing the training; and
- (e) if so, the details thereof and if not, the reasons therefor?

#### **ANSWER**

# MINISTER OF STATE (INDEPENDENT CHARGE) IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI RAJIV PRATAP RUDY)

(a) to (e) A Statement is laid on the Table of the House.

STATEMENT REFERRED TO IN REPLY TO PARTS (A) TO (E) OF LOK SABHA STARRED QUESTION NO. 60 TO BE ANSWERED ON 27.04.2016 ASKED BY SHRIMATI RANJEET RANJAN AND SHRI RAJESH RANJAN REGARDING 'PRADHAN MANTRI KAUSHAL VIKAS YOJANA'.

- (a) & (b) Pradhan Mantri Kaushal Vikas Yojana (PMKVY) is being implemented through National Skill Development Corporation (NSDC). The trainees are issued certificate by concerned Sector Skill Councils (SSCs) after their successful training and assessment under PMKVY. The entire process and progress of PMKVY is tracked by NSDC on its IT Portal-Skill Development Management System. As per data available, out of 8.44 lakh students who have successfully completed training and assessment, 5.71 lakh students have already been issued certificates. The certification by SSCs is still going on and students are getting certified. There are certain factors like assessment reports, non-availability of Aadhar IDs, processing of data which consume a lot of time in certification. The Government has instructed NSDC to ensure issuance of certificate to candidates as soon as they become eligible. NSDC has also been following up with SSCs for expediting certification.
- (c) PMKVY was formally launched by the Hon'ble Prime Minister on 15<sup>th</sup> July 2015 initially for a period of one year. A monetary reward is directly credited to the Bank account of trainees upon their successful assessment and certification. As on 22<sup>nd</sup> April 2016, some 8.44 lakh students have been certified out of which only 3.09 lakh trainees have bank accounts against which reward money has been disbursed to 2.11 lakh candidates till date. Remaining candidates would be given Reward Money after their aadhar validation and opening of Bank Accounts.
- (d) & (e) Placements under PMKVY is tracked through the Skill Development Management System (SDMS) portal. As per the data declared by the training partners on SDMS portal, a total of 70,927 candidates have so far been placed under PMKVY.
