STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (d) OF LOK SABHA STARRED QUESTION NO. 67 FOR ANSWER ON 28.04.2016 ASKED BY SHRI B.V. NAIK REGARDING CENTRAL ROAD FUND

(a) The funds accrued under the Central Road Fund (CRF) during 2013-14, 2014-15 and 2015-16 were Rs. 19,263 crore, Rs. 26,108 crore and Rs. 69,809 crore (provisional) respectively.

This Ministry is primarily responsible for development and maintenance of National Highways (NHs). Apart from this, the Ministry also allocates funds for development of State Roads and Roads of Economic Importance and Inter State Connectivity (EI&ISC) as per the provisions of the CRF Act, 2000. Year wise details of accrual/allocation of funds to States / Union Territories (UTs) and expenditure/release of funds under these schemes during the last three years are as follows:

(b) The State-wise details of projects approved / sanctioned for development of State Roads under CRF and EI&ISC schemes during the last three years is at **Annexure-I.**

The development of NHs under various phases of National Highways Development Project (NHDP) is financed through NH share of CRF Cess, Toll Remittances and funds raised through Internal & Extra Budgetary Resources (IEBR) by National Highways Authority of India (NHAI). Part of NH share of cess under CRF was also used for development of other NHs during the above period. However, specific details of State/UT wise NH projects financed through CRF are not maintained.
