Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the number of Central Government Health Scheme (CGHS) dispensaries/ wellness centres functioning along with the sanctioned strength and actual strength of Unani/Ayurvedic/Allopathic doctors and paramedical staff, State/UT-wise as on date;
- (b) whether the Government proposes to open more such wellness centres/ dispensaries and also appoint more doctors in such centres/dispensaries, if so, the details thereof, location and State/UT-wise including Maharashtra and Tripura;
- (c) whether the CGHS Ayurvedic Dispensaries are facing shortage of Ayurvedic medicines during the last three years, if so, the details thereof and the reasons therefor;
- (d) whether the Government has received complaints regarding irregularities in such dispensaries/wellness centres during the last three years, State/UT-wise; and
- (e) if so, the details thereof and the action taken by the Government against the erring staff along with the preventive steps taken by the Government to check such corrupt practices?

# ANSWER THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI JAGAT PRAKASH NADDA)

(a) Details of CGHS Dispensaries /wellness centres functioning alongwith the sanctioned strength and actual strength of paramedical staff are at Annexure – A & B respectively.

The information relating to sanctioned strength and actual strength of AYUSH/Allopathic doctors under CGHS dispensaries/Wellness centres is being collected and will be laid on the Table of the House.

(b): Yes. Orders have been issued on 17.11.2014 for opening of CGHS Wellness Centres at the following locations:

Raipur, Shimla, Itanagar, Panaji, Agartala, Imphal, Aizwal, Kojima, Gangtok, Gandhi Nagar, Puducherry, Indore.

Appointment of doctors as per sanctioned strength will be done as and when these Wellness Centres are made functional.

- (c): Yes, there was shortage in supply of Ayurvedic medicines to Wellness Centres for some period during the year 2014-15 due to shifting of Ayurvedic Medical Store Depot from Bikaner House to Shahdara.
- (d) & (e): Yes, some complaints have been received regarding irregularities in CGHS dispensaries/Wellness Centres.

Appropriate action is taken as per rules in cases where irregularities are proven.

Following preventive steps have been taken to check such corrupt practices:

- (i) 100% Physical verification is carried out annually by Internal Audit Unit (IAU) in each and every CGHS Wellness centre.
- (ii) Random surprise inspection is done by Vigilance Team from time to time.
- (iii) Additional Directors make surprise visits to the dispensaries for checking any irregularities and functioning of Wellness Centres.
- (iv) CGHS beneficiaries receive SMS alert on their registered Mobile phone as and when medicines are issued against their Ben-ID No. This acts as a deterrent against pilferage of medicines by unscrupulous elements.
