Cooperation of Foreign Institutions in Research

Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) the number of foreign institutes which have agreed to extend cooperation to improve the quality of research in the universities and other educational institutions in the country;
- (b) the steps taken by the Government to promote the participation of private sectors in research and development in the country;
- (c) the steps taken by the Government to increase the representation of female students and the students belonging to the minorities and backward tribal areas in the country; and
- (d) the funds allocated to encourage these sections of society during the last three years?

ANSWER

MINISTER OF HUMAN RESOURCE DEVELOPMENT (Smt. Smriti Zubin Irani)

(a) The University Grants Commission (UGC) has implemented a number of Joint Research Programmes between higher education institutions in India and foreign education institutions. Presently, 144 foreign educational institutions are involved in collaborative Joint Research Programmes. The number of foreign institutions involved in research and academic collaboration with Indian institutions (Programme/Country-wise) is as follows:-

(b): The endeavour of the government has been to make affordable and quality education available to the eligible population in the country by expanding education facilities both in government and private sector. A Scheme for setting up 20 new Indian Institutes of Information Technology (IIIT) on PPP model was approved on 07.12.2010, with an outlay of Rs.2808.71Crores. The capital cost of each IIIT is Rs.128.00 Crore to be contributed in the ratio of 50:35:15 by the Central Government, the State Government and the industry respectively (57.5:35:7.5 in case of North-Eastern region). Concerned State Government will provide 50-100 acres of land, free of cost and encumbrances. So far, 12 IIITs have commenced their academic programmes.

Hon'ble Minister for Human Resource Development announced UCHCHATAR AVISHKAR YOJANA in the IIT Council meeting on October 6, 2015 at an annual investment of Rs. 250.00 crore with a view to promoting innovation of a higher order that directly impacts the needs of the Industry and thereby improves the competitive edge of Indian manufacturing. The Scheme would be applicable to the projects proposed by IITs initially. The projects should have collaboration between the academia and industry – within or outside India. The funding pattern of the projects selected would be 25% by Industry, 25% by participating Department/Ministry and 50% by Ministry of Human Resource Development. IIT-Madras is the National Co-ordinator of the Scheme.

(c): The Ministry of Human Resource Development has several schemes to promote educational development of marginalized sections of the society, including minorities and women. The Scheme for Providing Quality Education for Madarsas (SPQEM) and Scheme of Infrastructure Development in Minority Institutions (IDMI) are exclusively for educational development of minorities. Under Rashtriya Madhyamik Shiksha Abhiyan (RMSA) and Sarva Shiksha Abhiyan (SSA) special provisions have been made to cater to the needs of minorities and girls. In Rashtriya Ucchatar Shiksha Abhiyan (RUSA), financial assistance is given for establishment of polytechnics, women hostel and Model Degree Colleges in Minority Concentration Districts (MCDs) also.

The University Grants Commission (UGC) has the following schemes for the benefit of minority communities and women:-

- (i) Remedial Coaching for SC/ST/OBC (Non-Creamy Layer) and Minority Community Students;
- (ii) Coaching for National Eligibility Test (NET)/State Eligibility Test(SET) for SC/ST/OBC (Non-Creamy Layer) and minority community students;
- (iii) Coaching Classes for entry into services SC/ST/OBC (Non-Creamy Layer) and minority community students;
- (iv) Coaching Classes for Residential for Minorities/SC/ST and Women.
- (v) Indira Gandhi Scholarship for Single Girl Child for Pursuing Higher and Non-Technical Education;
- (vi) Post-Doctoral Fellowships for Women
- (vii) Swami Vivekananda Single Girl Child Scholarship
- (viii) Construction of Women's Hostels for Colleges

- (ix) Development of Women's Studies in Universities and Colleges
- (x) Rajiv Gandhi National fellowships for SC/ST students
- (xi) Post-graduate scholarships for SC/ST students
- (xii) Post-doctoral fellowships for SC/ST students
- (xiii) Establishment of Equal Opportunity Cells in universities
- (xiv) Establishment of centres in universities for study of Social Exclusion and Inclusive Policy.

The All India Council for Technical Education (AICTE) gives concessions in setting up new technical institutions under the category of minority institutions to encourage minorities to establish new educational institutions and thus enable easy access to technical education to minority students in the country. AICTE has launched a Scheme titled 'PRAGATI' in November, 2014 for providing assistance for advancement of girls' participation in technical education.

The Ministry of Minority Affairs implements Post-Matric Scholarship Schemes for Class XI to Ph.D., Merit-Cum-Means (MCM) scholarships for professional and technical courses for higher education of minorities and Maulana Azad National Fellowships to Minority students pursuing M.Phil/Ph.D in universities/colleges. Under the 'Padho Pardesh Scheme' of the Ministry of Minority Affairs, interest subsidy on educational loan for overseas studies is provided. In all scholarship/fellowship schemes of the Ministry of Minority Affairs, a minimum 30% of the seats are earmarked for girls.

The Ministry of Social Justice and Empowerment and Ministry of Tribal Affairs have scholarship schemes for SC/ST students like Post Matric scholarship for SC/ST students, Central Sector Scholarship Scheme of Top class Education for SC/ST students and National Overseas Scholarship for SC/ST students.
