- (a) & (b):** Yes, Madam. The Foreign Direct Investment (FDI) equity inflow has increased from US\$ 22.42 billion in 2012-13 to US\$ 37.53 billion in 2015-16 (up to Feb. 2016). The Sector-wise, year-wise details of FDI equity inflow received during the period is enclosed as Annexure A.
