(a) to (b): Yes Madam. This Ministry has received some complaints from some of the officials and faculty members of National Institute of Technology (NIT), Uttarakhand during last three years received through various organizations. The list of complaints received during the last three years and the current year is at Annexure.

(c): The following steps have been taken to improve the administrative and academic performance of all thirty one NITs including NIT, Uttarakhand: -

- (i) Four-Tier Flexible Faculty Structure has been implemented in NITs.
- Encourage top 15% of Under Graduate students to join as "Trainee-Teachers" at NITs.
- (iii) Driving best Under Graduate students in the country to be NIT faculty tomorrow.
- (iv) Motivating best students early towards Research and Development Career.
- Live delivery of High Quality Classes in classrooms using video on DTH and highspeed Internet; Placing the best teachers in front of students.
- (vi) Driving Excellence amongst faculty through Continuous Teacher Traineeprograms and Certifications including faculty appraisal.
- (vii) External Institute Evaluation-Departmental Visiting Committee Visits towards enhancing academic and research programs in the department.
- (viii) Industry personnel to use video to teach remote classes at NITs.
- (ix) The vacant position of Registrar has been filled up on regular basis in NIT, Uttarakhand.
