RELAXATION IN PROCUREMENT NORMS

1462. SHRI DEVAJIBHAI G. FATEPARA:

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION उपभोक्ता मामले, खाद्य और सार्वजनिक वितरण मंत्री be pleased to state:

(a) whether the Government has relaxed the procurement quality norms for procurement of foodgrains for central pool to provide relief to the farmers and protect them from distress sale on account of unseasonal rains during the last and the current year, if so, the details thereof, State/UT-wise;

(b) whether the Government has received complaints of irregularities in procurement of foodgrains under relaxed norms during the said period, if so, the details thereof along with the action taken/ being taken by the Government on such complaints, so far; and

(c) the steps taken by the Government to ensure remunerative prices for the foodgrains produced by the farmers?

ANSWER

MINISTER OF CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SHRI RAM VILAS PASWAN)

(a): Yes Madam. Details of relaxations in quality norms for procurement of Central Pool foodgrains allowed during last year are at Annex. During Rabi Marketing Season (RMS) 2016-17 no State Government has requested for relaxations in specifications of foodgrains for Central Pool procurement.

(b): No complaint of irregularities in procurement of foodgrains under relaxed norms has been received during last year and current year. However, complaints on procurement below MSP, non opening of purchase centre, delay in payment of MSP etc. The complaints were investigated and found not substantiated.

(c): Government/FCI alongwith State Governments formulate procurement plans to procure foodgrains from the farmers. In plans following steps are included:

- 1. Government announces Minimum Support Price(MSP) for foodgrains in each season to ensure remunerative prices to the farmers with a view to encourage higher production. Government offers procurement at MSP.
- 2. MSP operations are given wide publicity through pamphlets, banners, sign boards radio, TV and advertisements through print & electronic media about quality, specifications, purchase system etc to create awareness among farmers.
- 3. Procurement centres are opened by respective State Govt. Agencies/FCI taking into account the production, marketable surplus, convenience of farmers and availability of other logistics/infrastructure such as storage and transportation etc.
- 4. Payments are made through account payee cheque/RTGS to the farmers.
