- (a)the number of Employees State Insurance (ESI) hospitals/dispensaries functioning in the country at present including the details and total number of beneficiaries, State/UT-wise including Uttar Pradesh;
- (b)whether the Government proposes to equip ESI hospitals with super specialty facilities and if so, the details thereof;
- (c)whether the Government also has any proposal to set up new Super Specialty Hospitals/Medical Colleges under ESI in the country, State/UT-wise including Uttarakhand;
- (d)if so, the details of locations identified, State/UT-wise including Uttar Pradesh along with the time by which the said hospitals are likely to start functioning;
- (e)whether the Government is aware about the shortage of Medical and Paramedical staff in ESIC hospitals in the country, and if so, the details thereof, State/UT-wise; and
- (f)the corrective action taken/being taken by the Government in this regard?

ANSWER

MINISTER OF STATE (IC) FOR LABOUR AND EMPLOYMENT (SHRI BANDARU DATTATREYA)

(a): The details of number of Employees State Insurance (ESI) hospitals/dispensaries functioning in the country at present is at Annexure-I & II.

The details and total number of beneficiaries State/UT-wise including Uttar Pradesh is at Annexure-III.

- (b): The ESI Corporation has listed various programmes for implementation under 2nd Generation Reform under which ESIC Hospitals are to be equipped with the following super specialty facilities:
 - Cardiology treatment facilities.
 - Dialysis facilities.
 - Cancer detection/ treatment facilities.
- (c) & (d): The ESI Corporation in its 167th meeting has taken a decision to run one super specialty hospital in every State. Further, during same meeting, in-principle approval has also been given for setting up of a Super Speciality Hospital at Pandu Nagar, Kanpur, Uttar Pradesh. There is no proposal to start new Medical College.
- (e): Yes, Madam. Present status of Doctors (GDMO), Specialists and Nursing-Paramedical in ESI Corporation is as under:

State & hospital-wise details staff is at Annexure -IV.

- (f): In order to safe guard the delivery of health care services to ESI beneficiaries, ESI Corporation has taken following steps:-
- i. 40% of the sanctioned posts under the GDMO sub cadre in ESIC hospitals are being filled with Senior Residents by Medical Superintendents locally.
- ii. In addition, 10 Senior Residents posts per 100 beds have also been sanctioned over and above the sanctioned post of GDMOs. These are also filled by Medical Superintendents locally.
- iii. The Medical Superintendents have been authorized to recruit super specialists and specialists on contract basis till the regular incumbents become available.

- iv. Medical Superintendents of ESIC hospitals were also authorized to engage, under certain situations, retired Nursing and Para-Medical staff or to hire such personnel through agencies on short term basis.
- v. Regular recruitment process has been initiated to fill up vacant post of ESIC hospitals.
- vi. ESIC has since decided to engage the services of EdCIL INDIA (a PSU under administrative control of Ministry of HRD, Government of India) Limited, for expeditiously completing the recruitment process.
- vii. 84 offer of appointments to Doctors (GDMOs) have been issued.
- viii. Process for recruitment of 450 GDMOs and 286 Specialists have been initiated.
 - ix. Advertisements for recruitment (808+1680=2488) of Nursing & Para-Medical cadre have been issued.
 - x. Entering into tie-up arrangement with private/public hospitals for the medical services, which are not available in ESIC hospitals.
