Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the details of programmes/training being started by National Skill Development Council and the total number of training centres proposed to be opened by the Government and the number of centres opened so far, State-wise;
- (b) the number of institutions/ companies/Non-Government Organisations collaborating with the operationalisation of skill development training centre, institution-wise details thereof;
- (c) whether the concerned institutions have set up centres as per the fixed target for skill development training by the Government;
- (d) if not, the reaction of the Government thereon; and
- (e) whether the Government has received any complaints regarding not opening training centres by various institutions and if so, the number of institutions against whom action has been taken, institution-wise?

(a) to (d) National Skill Development Corporation (NSDC) under Ministry of Skill Development and Entrepreneurship is implementing Skill Development Programs namely Pradhan Mantri Kaushal Vikas Yojana (PMKVY) and UDAAN. In addition it is providing training under the projects of Public Sector Undertakings and Private Organisations. NSDC also provides soft loans for setting up training centres across the country. Under PMKVY, NSDC has a total of 8179 Operational Training Centres across the country as on 31st March 2016. A list of State/ UT wise Operational Training Centres for the financial Year 2015-16 as on 31st March, 2016 is **annexed**. NSDC has 267 training partners as on 3rd May 2016. Under PMKVY, 17.93 lakh candidates have been enrolled and 17.58 lakh training completed as on 25th April, 2016.

(e) The SBICAPS, monitoring agency of National Skill Development Fund (NSDF) for monitoring activities of NSDC, has reported cases of Non-Performing Assets / defaults by the Training Providers. NSDC has been directed to closely monitor the grants of defaulter training partners/cases of non-performing assets. Further, NSDC has been directed to fulfil all the conditions stipulated in the Investment Management Agreement signed between NSDF and NSDC and bring such cases to the notice of NSDF.
