- (d) the details of steps taken to strengthen security arrangements for passengers?

- (a) and (b): The details of various crimes registered by Government Railway Police in Railways and the details of Railway employees and other related staff involved during the year 2013, 2014 and 2015, zonewise, are appended.
- (c): The number of incidents of carelessness and alleged extortion by Railway Protection Force were 37 in 2013, 27 in 2014 and 43 in the year 2015.
- (d): Measures initiated by the RPF to strengthen security over Railways, in coordination with Government Railway Police of respective States include escorting of trains, access control, prosecution of offenders under relevant provisions of the Railways Act, operationalisation of Security Helpline (182), surveillance over about 311 stations through close circuit television camera, networking of Security Control Rooms and Railway Protection Force Posts, implementation of Integrated Security System over identified stations, regular drive to apprehend and prosecute offenders under the Railways Act, 1989, etc.
