Will the Minister of COMMUNICATIONS AND INFORMATION TECHNOLOGY be pleased to state:

- (a) the details of mobile subscribers separately of GSM and CDMA in the country, State and operator-wise;
- (b) whether Telecom Regulatory Authority of India (TRAI) while taking into consideration the growing number of mobile users has formulated special plan for expansion and improvement of telecom services;
- (c) if so, the details thereof; and
- (d) the schemes launched and funds allocated for the same, State-wise along with the investment made by the telecom service providers for expansion of telecom and internet facilities during the last three years and the current year, circle and operator-wise?

ANSWER

THE MINISTER OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (SHRI RAVI SHANKAR PRASAD)

- (a) As regards details of mobile subscribers, Licenses are issued by DoT service-area wise and not state-wise. The service-area wise and operator-wise subscriber base of Wireless Services (GSM and CDMA) ending February 2016 is given in **Appendix-I**
- **(b)&(c)** As regards measures taken for expansion of telecom services, TRAI has issued various recommendations which are as follows:
 - (i) The TRAI has recommended roll out obligations against allotment of spectrum, from time to time.
 - (ii) TRAI had submitted its recommendations on "Improving Telecom Services in the North-Eastern States: An Investment Plan" to the Government on 26th September 2013. The press release highlighting the details of these Recommendations , (Recommendations on "Improving Telecom Services in the north eastern status: An Investment Plan" dated 26th September 2013) as available on the TRAI website may kindly be referred to.

- (iii) Further, TRAI had submitted its recommendations on "Improving Telecom Services in Andaman & Nicobar Islands and Lakshadweep" to the Government on 22nd July 2014. The press release highlighting the details of these Recommendations,(Recommendations on "Improving Telecom Services in Andaman & Nicobar Islands and Lakshadweep" dated the 22nd July, 2014) as available on the TRAI website may kindly be referred to.
- (iv)TRAI has laid down Quality of Service Standards which are to be adhered to by the Telecom Service Providers (TSPs).
- (d) Government has approved a project at a cost of Rs. 5336 Cr to cover 8621 uncovered villages in the country in the North Eastern States.

Telecom Commission has recommended a project to provide submarine optical fibre connectivity between Chennai, Port Blair and five other islands at a capital cost of Rs. 880Cr. These projects are to be funded from USOF.

The details of Gross Block and the Capital Work in progress of various TSPs as obtained from TRAI are placed at **Appendix-II**.
