NABARD Loan for Irrigation Projects

†2080. SHRI RAM SWAROOP SHARMA:

Will the Minister of FINANCE be pleased to state:

- (a) the details of funds allocated/ provided by the National Bank for Agriculture and Rural Development (NABARD) for irrigation projects in the country during each of the last three years, State-wise; and
- (b) the time by which the said projects are likely to be completed along with the details of the amount spent on the projects?

Answer

- (a): The State-wise details of the loans sanctioned by National Bank for Agriculture & Rural Development (NABARD) for irrigation projects under Rural Infrastructure Development Fund (RIDF), for the last three years, are given in Annex-I.
- (b) NABARD has reported that the projects under irrigation sector are sanctioned with a phasing period of 3-5 years and 95% of expenditure incurred is disbursed as RIDF assistance. Keeping in view the phasing of irrigation projects for implementation (3 years for minor irrigation and 5 years for medium/major irrigation Projects), the projects sanctioned under RIDF XIX (2013-14) will be completed between 2017-2019, projects sanctioned under RIDF XX (2014-15) will be completed between 2018-2020 and projects sanctioned under RIDF XXI (2015-16) will be completed between 2019-2021.

The State-wise details of the loan amount disbursed by NABARD for irrigation projects under RIDF during the last three years are given in Annex-II.
