Will the Minister of FINANCE be pleased to state:

- (a) the amount released to States under various heads as recommended by the Central Finance Commissions during each of the last three years;
- (b) the amount of cesses and surcharges collected and appropriated for these purposes, during the same period;
- (c) the differential costs to be made to States on account of pay revision of employees; and
- (d) if so, the details thereof?

ANSWER

MINISTER OF STATE FOR FINANCE (SHRI JAYANT SINHA)

- (a) During the last three years, award periods of the two Central Finance Commissions were in force. In 2013-14 and 2014-15 recommendations of the Thirteenth Finance Commission (award period 2010-15) were being implemented and during 2015-16 recommendations of the Fourteenth Finance Commission (award period 2015-20) were being implemented. The details of amount released to States including Grant –in-aid as recommended by the respective Finance Commission during the last three years are given in **Annexure-I.**
- (b) The amount of cesses and surcharges collected are not shareable with the States, therefore not appropriated for these purposes.
- (c) & (d) No such proposal is under consideration.
