#### 2477. SHRI C. MAHENDRAN:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) the details of the infrastructure at present available in tribal area schools in the country, State/UT-wise including Tamil Nadu;
- (b) whether the Government has any proposal/proposes to develop infrastructure in tribal area schools;
- (c) if so, the details thereof along with the funds sanctioned, allocated and released for the said purpose during each of the last three years, State/UT-wise; and
- (d) whether the Department of Forest has raised objections against development/establishment of schools in forest areas and if so, the details thereof and the reaction of the Government thereto?

- (a) & (b) The Ministry of Tribal Affairs provides funds between 50% and 100% of the construction cost of Ashram Schools under its scheme of Establishment of Ashram Schools in TSP Areas. It also provides for construction and day to day running of Ekalavya Model Residential Schools under Article 275(1) of the Constitution. It also provides for construction of boundary walls, setting up of computer and science laboratories, sports infrastructure, etc. These are provided on the basis of the assessment made by the State Governments.
