- (a): Rashtriya Gokul Mission has been initiated with an allocation of Rs 500 crores during the remaining three years of the 12th Plan period from 2014-15.
- (b): The details of the funds budgeted, released and utilized so far for the said scheme, State/UT-wise including Uttar Pradesh is given in Annexure-I.
- (c): The integrated cattle development centres are being established in the State of Andhra Pradesh, Chhattisgarh, Gujarat, Haryana, Madhya Pradesh, Maharashtra, Nagaland, Odisha, Punjab, Rajasthan, Telangana and Uttar Pradesh.
