MISMANAGEMENT OF PUBLIC MONEY

2595. SHRI R.K. SINGH:

Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether Delhi being a Union Territory, the Ministry of Home Affairs has the responsibility in checking any gross mismanagement of public money in the Union Territory and if so, the details thereof;

(b) whether the Ministry is aware that huge amount of public funds are being wasted on publicity by the UT administration and the publicity is personality oriented in violation of the Supreme Court order;

(c) the details of the budget and expenditure by the UT administration on publicity through television, radio and newspapers over the last two financial years as compared to previous years; and

(d) the expenditure on publicity on the last two Odd and Even exercises to reduce the private vehicles on the roads?

(a) The expenditure incurred by the Govt. of NCT of Delhi is subject to audit. As per Section 48 of the Government of NCT of Delhi Act, 1991, the reports of Comptroller and Auditor-General of India relating to the accounts of the Capital are submitted to the Lieutenant Governor who causes them to be laid before the Legislative Assembly.
