SECURITY OF DELHI METRO

2692. SHRI P.R. SUNDARAM:

Will the Minister of HOME AFFAIRS be pleased to state:

(a) the existing strength and requirement of security personnel in Delhi Metro;

(b) whether violation of security rules has increased every year in Delhi Metro;

(c) if so, the details thereof and the total number of such cases reported and the action taken against the guilty personnel during each of the last three years and the current year;

(d) whether the Government has also received complaints that people are entering metro stations without proper frisking and getting their bags checked;

(e) if so, the details thereof and the action taken in this regard; and

(f) the corrective steps taken by the Government to improve security in Delhi Metro along with the other measures taken to check recurrence of such cases in future?

ANSWER

(a): The existing deployment of the Central Industrial Security Force (CISF) personnel in Delhi Metro is 6426. The requirement of personnel in Delhi Metro, as projected by CISF, is 2120 additional posts for Phase I and II, and 4688 posts for Phase III.

(b) and (c): No, Madam. The details of number of cases reported and action taken are at Annexure-‘A’.

(d) and (e): In this regard, CISF Unit Delhi Metro, has received following complaints:

In all these cases, the complaints were thoroughly inquired into. Although all the complaints were found to be misplaced, instructions for increased vigilance during checking, have been reiterated.

(f): CISF and the Delhi Metro Rail Corporation (DMRC) have taken the following corrective steps to improve security and check recurrences of security-related cases, include-

- (i) Review of physical security infrastructure by a Committee,**
- (ii) Security review and sharing of inputs with all stake-holders and implementation of preventive measures,**
- (iii) Annual internal security audit of the CISF unit, DMRC,**
- (iv) Bi-annual security audit by the central security agencies,**
- (v) Security review during heightened alert situations, based on threat**

perception,

(vi) Increased Closed Circuit Television (CCTV) coverage,

(vii) Deployment of Quick Reaction Teams (QRT),

(viii) Sensitization and training of personnel for detection of breaches and quick action thereon.
