2967. SHRI SANJAY DHOTRE: SHRI BHARTRUHARI MAHTAB:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) whether the Union Government and the Indian companies have signed Memoranda of Understanding (MoU) to promote skill development initiatives under Corporate Social Responsibility (CSR);
- (b) if so, the details thereof along with the amount spent by the said companies for the purpose since signing the MoUs, company-wise;
- (c) the number of persons who availed benefits of such skill development initiatives across the country since inception of the MoUs, State/UT-wise;
- (d) whether the violation of the said MoUs by any of the companies have come to the notice of the Government during the said period and if so, the details thereof, company-wise along with the action taken/ being taken by the Government against such companies so far; and
- (e) the other efforts taken/being taken by the Government to ensure strict adherence to terms and conditions of the MoUs by the said companies in the country?

ANSWER

MINISTER OF STATE (INDEPENDENT CHARGE) IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI RAJIV PRATAP RUDY)

- (a) to (b) National Skill Development Corporation (NSDC) under Ministry of Skill Development and Entrepreneurship (MSDE) has signed Memorandam of Understanding (MoU) with several PSUs and Corporates to promote skill development initiatives under Corporate Social Responsibility (CSR). Most of the MoUs are tripartite agreement between, National Skill Development Fund (NSDF), NSDC and the Companies. Details of MoUs signed and funds received are at **Annexure-I.**
- (c) So far, 4757 persons have been trained and 5291 are undergoing training under there MoUs. Project wise details are at **Annexure-II**.
- (d) No such violation of the said MoUs by any of the companies have been reported by NSDC to the Ministry.
- (e) MSDE actively monitors the progress of projects. Other Ministries also monitor the progress of CSR Projects funded by PSUs under their Ministry. Moreover, National Skill Development Fund (NSDF) under MSDE transfers the agreed amount to NSDC after ensuring adherence to terms and conditions of the MoUs.
