- (b) Department of Science and Technology (DST) has been implementing Patent Facilitation Programme through Patent Facilitation Cell (PFC) established in 1995 at Technology Information Forecasting and Assessment Council (TIFAC), an autonomous institute of DST. In addition, 26 Patent Information Centers (PICs) have been established in various states for creating awareness and extending assistance on protecting Intellectual Property Rights (IPR) including patent, copyright, geographical indication etc. for academic sector. These PICs are also creating Intellectual Property Cells in Universities (IPCU) in their respective states. As of now, 71 IPCU's have been created in different universities of the states. Government has not proposed to allocate more funds to Patent Facilitation Cell.
