WORKS STALLED UNDER PMGSY

710. SHRI LAXMI NARAYAN YADAV:

Will the Minister of **RURAL DEVELOPMENT** be pleased to state:

- (a) whether the work relating to the road construction under the Pradhan Mantri Gram Sadak Yojana is stalled in Madhya Pradesh due to paucity of funds;
- (b) if so, the details thereof and the steps taken/proposed by the Government thereon; and
- (c) the efforts made by the Government to provide funds for construction of roads under PMGSY in Madhya Pradesh?

ANSWER

(a) to (c): Pradhan Mantri Gram Sadak Yojana (PMGSY) suffered from extreme paucity of fund during first 3 years of 12th plan period i.e. from 2012-13 to 2014-15. The budget of PMGSY was substantially reduced during the year 2012-13 and 2013-14 at Revised Estimate (R.E.) stage. During the year 2014-15 an amount of Rs. 14,200 crore was allocated to PMGSY. Consequently a large number of pending liabilities remained at the level of the States. During the year 2015-16, Rs. 14,291 crore was allocated to PMGSY, which was substantially enhanced to Rs. 18,291 crore at R.E. stage. Rs. 19,000 crore have been allocated for PMGSY for the year 2016-17.

With the new funding pattern that has been brought into place from the year 2015-16, the funds would be released by the Centre and the State in a 60:40 ratio in all the States except the Hill States and North Eastern States where the pattern would be 90:10. This has improved the fund availability with the States including Madhya Pradesh, under PMGSY.

The funds that have been released/allocated to Madhya Pradesh during each year of the 12th year plan is as follows:
