- (f) if so, the details thereof and the time by which the committee is likely to submit its report; and
- (g) the income and expenditure of Air India during the last three years and the current year, year-wise and the reasons for losses suffered by Air India?

(a) & (b): The domestic market share of Air India in the last 03 years is given as under:

The market share of Air India has declined in the last three years. There has been capacity induction to Air India whereas the capacity of competitor Airlines has grown substantially in the domestic market. The capacity in domestic market of Air India is not in line with the capacity induction by the competitors. The capacity share of Air India in 2013-14 was 17% which has come down to 15% in FY 2015-16.

(c): Air India Ltd was formed with the merger of erstwhile Indian Airlines and erstwhile Air India Ltd w.e.f. 2007-08. Both these erstwhile companies were in profit during 2003-04 to 2005-06. However, during FY 2006-07 both the companies suffered losses. The details of the year-wise Profit/Loss are given as under:

- High interest burden

- Increase in competition especially from low cost carriers

- High Airport User Charges

- Adverse impact of exchange rate variation due to weakening of the Indian Rupee.
