Will the Minister of **DRINKING WATER AND SANITATION** be pleased to state:

- (a) whether the Government has made any assessment of the progress made under Swachh Bharat Mission(SBM);
- (b) if so, the details of the success achieved so far under SBM, State-wise;
- (c) whether SBM is facing resistance in sidestepping the inhuman practices of manual scavenging and if so, the details thereof and the reaction of the Government thereto;
- (d) the details of the funds released and utilised under SBM/Sanitation Schemes during each of the last three years and the current year, State-wise; and
- (e) whether the Government has accelerated its efforts or has introduced innovative ideas/monetary rewards under SBM to achieve its objectives, if so, the details thereof?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF DRINKING WATER & SANITATION

(SHRI RAM KRIPAL YADAV)

(a) and (b) Ministry of Drinking Water and Sanitation regularly reviews the programme. Since the launch of SBM(G), there is a spurt in the progress made under the programme. Against the expected outcome of **50 lakh** for individual latrines for the year 2014-15, **58,54,987** latrines were constructed, which is an achievement of **117%** of the target. During 2015-16, **127.41 lakh** toilets have already been constructed as on 31.03.2015. Since the launch of Swachh Bharat Mission(Gramin) on 2nd October, 2014, **176.90 lakh** toilets have already been constructed upto 31.03.2016. A baseline survey was conducted in 2012-13 by the States, as per which, the rural

sanitation coverage was **38.81%**. This has increased to **51.80%** as on **31.03.2016**. Also, **13** districts, **178** blocks, **23045** Gram Panchayats and **54732** villages have been declared Open Defection Free (ODF) as on **31.03.2016**.

Swachh Bharat Mission (Gramin) is demand driven programme, hence State-wise targets are not set. However, State/UT-wise number of Individual household latrines (IHHLs) and Community Sanitation Complexes constructed from 2.10.2014 to 31.3.2016 is at Annexure-1.

- (d) State/UT-wise, Central share released and utilised under Nirmal Bharat Abhiyan/Swachh Bharat Mission (Gramin) during last 3 years and current year is at Annexure-2.
- (e) To accelerate the progress, a World Bank project has been sanctioned with a financial envelope of Rs.9000 core over five years. Under which States will be incentivized on the basis of their performance under Swachh Bharat Mission (Gramin).
