### **902. DR. A. SAMPATH:**

Will the Minister of **RURAL DEVELOPMENT** be pleased to state:

- (a) whether the Government has any proposals to undertake more plantation works under the Saansad Adarsh Gram Yojana (SAGY), if so, the details thereof, State/UT-wise;
- (b) whether the Government also proposes to provide vegetables and fruit plants to people under SAGY through the forest department; and
- (c) if so, the details thereof, State/UTwise?

## ANSWER MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI SUDARSHAN BHAGAT)

(a) : Yes Madam, we are providing more plantation under the Saansad Adarsh Gram Yojana (SAGY). Roadside plantations, tree plantation in accordance with local preferences in homesteads, schools and public institutions-including green walkways and social forestry are among the important environmental development activities in an Adarsh Gram as laid down in the Saansad Adarsh Gram Yojana Guidelines.
