Affiliation with CBSE

91. SHRI HARISH MEENA:

Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) the number of private schools who have approached Central Board of Secondary Education for their affiliation during the last three years and the number of schools affiliated during the said period, State and district-wise;
- (b) the number of schools denied/kept on hold for affiliation, State and district-wise; and
- (c) the criteria followed by the Government for giving or denying affiliation to the schools?

(a)& (b): State-wise details of the number of private schools that applied for affiliation and number of schools for which affiliation was granted/rejected/kept on hold during the last three sessions i.e. 2013-14, 2014-15 and 2015-16 are given in the statement annexed. The district-wise details are available on the website cbse.nic.in.

(c) : Applications for affiliation are scrutinized on the following essential criteria –

(i) School should be recognized by the State Government or the application should be forwarded by the States Government, or the school should have a No Objection Certificate from the State Government.

(ii) The School should be run/managed by a Society or Trust or Company registered under section 25 of the Companies Act, 1956 or the Congregation or other Religious Body controlling the Society/Trust/Company registered u/s 25 of the Companies Act, 1956.

(iii) The Trust or Society or Company registered under Section 25 of the Companies Act, 1956 and management running the school should be of non-proprietary character.

(iv) The School must have required land and building constructed on a part of land and proper playground on the remaining land.

(v) The school should have well qualified staff as per the norms of the Board.

(vi) The school in India must pay salaries and admissible allowances to the staff not less than the corresponding categories of employees in the State Government schools or as per scales etc. prescribed by the Government of India or as per the conditions laid down by the State Government. The schools outside India should pay salaries not lower than those of the teachers in government schools in that country or not less than the salaries and foreign allowances payable to Kendriya Vidyalaya Sangathan (KVS) teachers, if officially posted to that country.
