NCC units are working in the country as per the given mandate. Presently there are 800 National Cadet Corps (NCC) Units in the country. State / UT-wise details are at Annexure.

Assessment / review of functioning of NCC units located all over India is undertaken at the conferences of the Central Advisory Committee (CAC), Joint State Representative & Deputy Directors General (JSR&D), and State Additional Directors General / Deputy Directors General (ADsG / DDsG) which are coordinated by Headquarters Director General NCC. Details of last Conference held are as under:
