#### **REHABILITATION OF BEEDI WORKERS**

#### †\*202. SHRI SHYAMA CHARAN GUPTA:

Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a)whether closure of beedi factories/units has impacted the livelihood of the beedi workers and if so, the details thereof;
- (b)whether the Government proposes to rehabilitate and provide alternative employment to the beedi workers rendered unemployed due to closure of beedi factories and if so, the details thereof along with the expenditure incurred in this regard and beneficiaries therefrom, State/UT-wise;
- (c)whether the Government has any proposal to provide education
  - vocational training to such workers and if so, the details thereof; and
- (d)the other social security schemes being implemented for the benefit of beedi workers in the country?

## STATEMENT REFERRED TO IN REPLY TO PART (a) TO (d) OF LOK SABHA STARRED QUESTION NO. 202 FOR 01.08.2016 BY SHRI SHYAMA CHARAN GUPTA REGARDING REHABILITATION OF BEEDI WORKERS.

- a) No Madam. However, it is stated that several representations were received from the organisations representing Beedi Workers and Manufactures regarding the adverse consequences of the Ministry of Health and Family Welfare Notification No. GSR/727(E) dated 15.10.2014 prescribing 85% pictorial warning on the Beedi packets. In this regard a meeting was held with all stake holders on 21.04.2016 under my chairmanship and the concern of this Ministry was conveyed to the Ministry of Health and Family Welfare.
- b) & c) The Ministry of Labour and Employment has taken steps to impart vocational training to the Beedi Workers through modular employment scheme to provide them alternative source of income to improve their livelihood. The details of beneficiaries along with expenditure State/UT wise are at **Annexure-A**.
- d) The details of other social security schemes being implemented by this Ministry for the benefit of Beedi workers is at **Annexure B.**

Director General (Labour Welfare) office of Ministry of Labour & Employment, Govt. of India, is currently administering different schemes under Beedi Workers Welfare Fund for the welfare of Beedi Workers.

At present there are 17 Welfare Commissioners covering all the States for effective implementation of the fund. Since the traditional employment of beedi making is perishing slowly an endeavor to provide alternate employment to beedi workers has been initiated in the year 2008-09.

- 2. As a part of this initiative a project to provide vocational training to these workers have been initiated in the different regions of Labour Welfare Organisation with the help of the various agencies working for this purpose.
- 3. As a result of the initiatives undertaken by the Welfare Commissioners some beed workers have been provided with alternate employment. In some of the regions this scheme is still continuing and efforts are being taken to provide sufficient fund to run the scheme in all the regions. The region-wise initiatives undertaken by the Welfare Commissioners since 2008-09 are as under:

Also, after this training the union leader of the area had talks with nearby garment factory owners, who promised to give their work to these workers and 75% of these workers are now employed in the nearby garment factories.

#### SOCIAL SECURITY SCHEMES FOR BEEDI WORKERS

The following financial assistance under are being provided to the beedi workers and their families:-

#### 1. Group Insurance:

Beedi Workers are covered under group insurance scheme wherein a financial assistance of Rs.10,000/- in case of natural death/- and Rs. 25,000/- in case of accidental death is given by LIC.

#### 2. Financial assistance to the daughters of Widow/widowers of beedi workers.

Financial assistance of Rs. 5000/- is given to the widow/widower of the beedi workers under social security scheme for wedding of their first two daughters.

#### 3. Funeral expenses:

An amount of Rs. 1500/- is given for the funeral expenses of the deceased workers.
