- (a) whether the Government has undertaken a programme to fully computerize the Public Distribution System (PDS), link it with Aadhaar and clean up the family card data base to control the leakages;
- (b) if so, the details thereof including the time-frame fixed for its completion indicating the names of the States where it is fully implemented as on date;
- (c) whether the Government has received any request from some States for extension of the said time-frame in view of the problems faced in its implementation; and
- (d) if so, the details thereof and the response of the Government thereto?

- (a) Under 12th Five Year Plan (2012-17), Government has approved a plan scheme on 'End-to-end Computerization of TPDS Operations' which comprises of activities namely, digitization of ration cards/beneficiary and other databases, online allocation, computerization of supply-chain management, setting up of transparency portals and grievance redressal mechanisms etc. Besides above, States/UTs have been also requested to seed the Aadhaar numbers in Ration Card database and install devices for biometric authentication at Fair Price Shops, to control leakages.
- (b) Being a plan scheme, the project period is upto 31.3.2017 and States/UTs have been asked to complete the project within the stipulated time. A statement showing the present status of implementation of various activities of the scheme and seeding of Aadhaar in beneficiaries' data base and installation of E-Point of Sale devices, (State-wise) is annexed.
- (c) & (d) All States are at different stages of implementation of 'End-to-end Computerization of TPDS Operations' scheme, as can be seen from the progress at annexure.
