- (a) the major defence equipment exported to various countries by the Defence Public Sector Undertakings (DPSUs) and Ordnance Factories along with its value during the last three years and the current year, country-wise;
- (b) the extent of increase registered in the export of defence equipment to various countries by the DPSUs and Ordnance Factories during the said period;
- (c) whether any limit has been fixed for export of defence equipment manufactured by DPSUs and if so, the details thereof; and
- (d) the measures taken by the Government to augment the export capabilities of various DPSUs and Ordnance Factories?

**STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (d) OF
LOK SABHA STARRED QUESTION NO.81 FOR ANSWER ON
22.7.2016**

Some of the major defence equipments exported by Defence Public Sector Undertakings (DPSUs) and Ordnance Factories (OFs) are Patrol Vessels, Helicopters & their spares, Sonars & Radars, Avionics, Radar Warning Receivers (RWR), Small Arms, Small Caliber Ammunition, Grenades, Telecommunication equipments etc. The value of export during each of the last three years and the current year as obtained from DPSUs and OFs country-wise is at Annexure.

2. To encourage export, DPSUs have been permitted to export upto 10% of their annual production. For items, where there is a capacity constraint, if DPSUs export, they would be required to ramp up their capacity accordingly in subsequent year.

3. Government has taken several measures to promote export of defence equipments. Some of the measures to streamline the export process and enhance the export potential are as under:-

(i) Defence Export Strategy has been formulated and placed in the public domain. The Strategy provides for creation of an Export Promotion Body, engaging Indian Missions/ Embassies abroad in export promotion, export financing through line of credit etc., better use of offset policy, export of indigenously developed defence systems and streamlining of the export regulation process.

(ii) The list of military stores for the purpose of issuing NOC for export has been notified by the Government to remove ambiguity and to make the process transparent.

(iii) Standard Operating Procedure (SOP) for issue of No Objection Certificate (NOC) for export of military stores has been simplified and put in public domain. Requirement of Government signed EUC for export of parts and components and other non-sensitive military stores has been done away with.

(iv) The process of applying for NOC for export of military stores has been made on-line.

(v) Specific time frame has been prescribed in SOP for issue of NOC for export of military stores.

(vi) The provision of 'in-principle' approval for export of specific items to specific countries has been incorporated in the SOP to enable Indian companies to explore export opportunities in overseas markets.

(vii) The DPSUs/OFs also participate in International defence exhibitions in major countries like France, United Kingdom, Brazil, Japan, South Africa, Indonesia, Singapore, Thailand, Germany etc. to showcase their defence products and to explore business opportunities abroad.
