- (a) whether the Government is looking to identify products that endanger the environment and the safety, security and health of human beings in order to push product standardisation;
- (b) if so, whether the Ministry has prepared any list of such commodities which can be regularised for products quality;
- (c) if so, the details thereof; and
- (d) the action plan formulated by the Government in this regard?

(a) to (d): The Government has brought various products under compulsory BIS certification on the grounds of safety, security and health of human beings and protection of the environment. At present, 110 products are under compulsory BIS certification. The list of these products is placed at Annexure-I. Indian Standards for 7 more steel products have been notified to be brought under compulsory BIS certification w.e.f. 18 September 2016. The Government from time to time bring more products under compulsory BIS certification.

Further, 30 Electronic and Information Technology goods have been covered under compulsory registration scheme, on the grounds of electrical safety. The list of these products is placed at Annexure-II.
