Will the Minister of **RURAL DEVELOPMENT** be pleased to state:

- (a) the amount of funds allocated/ released to the States and utilized by them under the National Social Assistance Programme (NSAP) during the last three years and the current year, State/UT-wise;
- (b) whether the Union Government has received complaints regarding misappropriation of funds and violation of guidelines laid down under the programme during the said period;
- (c) if so, the details thereof; and
- (d) the action taken by the Government thereon?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI RAM KRIPAL YADAV)

(a) : A statement indicating funds released and utilized under National Social Assistance Programme during the last three years and the current year, State/UT wise is at Annexure-I.

(b) to (c): Under National Social Asisstance Programme(NSAP) the complaints received by the Union Government are sent to the concerned State/UT Governments for taking appropriate action as identification of beneficiaries, sanction and disbursement of benefit under the schemes of NSAP is done by the State/UT Governments.A statement indicating State wise complaints received is at Annxure-II.

(d): The grievances and requests received through Centralized Public Grievance Redress and Monitoring System(CPGRAMS) as well as physically, in respect of implementation of schemes under NSAP, are forwarded to the concerned State Government and UT Administrations for appropriate action. The Ministry of Rural Development has put in place mechanism to monitor the schemes through appointment of National Level Monitors(NLMs), Area Officer's visits, holding of State and District level Vigilance and Monitoring Committee Meetings and periodical Performance Review Committee(RC) meetings.
