(b) to (d) DND flyover and Yamuna Expressway are outside the purview of this Ministry as they are State Roads and are not part of National Highways. However, Ministry of Road Transport and Highways has issued notifications for discontinuation of fee collection at 15 Fee Plazas on National Highways in the state of Uttar Pradesh during the last two years.
