#### REVIEW OF AIBP

Will the Minister of WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION be pleased to state:

- (a) the extra area that has been brought under irrigation facility to accomplish the Accelerated Irrigation Benefit Programme (AIBP), State/UT-wise;
- (b) whether the Government is contemplating to review the AIBP during the current Five Year Plan;
- (c) if so, the details thereof; and
- (d) the manner in which the interests of States having low irrigation percentage are proposed to be protected?

#### **ANSWER**

THE MINISTER OF STATE FOR WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION (Dr. SANJEEV KUMAR BALYAN)

- (a) As per the information available with Central Water Commission (CWC), State-wise details of irrigation potential created through Major/Medium Irrigation Projects under Accelerated Irrigation Benefit Programme (AIBP) are given at Annexure.
- (b) to (d) Government of India has launched the Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) during 2015-16 to irrigate the agricultural fields. Under the AIBP, now a part of PMKSY, 99 projects having potential of 76.03 lakh ha. have been identified in consultation with States, to be completed in phases by Dec., 2019. Innovative funding mechanisms through NABARD are envisaged for completion of these projects in a mission mode.
