New Schemes launched during 12th Five Year Plan for the development of textile industry

1. **Trade Facilitation Center:** Setting up of Trade Facilitation Centre (TFC) and Crafts Museum (CM) to develop and promote handloom products and carry forward the traditions of handlooms of Varanasi was announced in 2014-15. The project is likely to be completed in all respects by 15th August 2017 with an outlay of Rs.281 crores.
2. **Scheme for In-Situ up-gradation of plain Powerlooms:** The scheme was launched in September, 2013 with a budget provision of Rs.32 crore at the BE stage with the prime objective to provide financial assistance to economically weaker low-end small powerloom units to improve quality and productivity of the fabric. Preference would be given to those units having maximum two to four looms in household units and / or within one shed among the eligible units.
3. **Integrated processing Development Scheme / (IPDS):** Integrated Processing Development Scheme (IPDS) has been approved in October 2013 at a total cost of Rs.500 crores for implementation during 12th Five Year Plan. The objectives of the Scheme is to enable the textile processing sector in meeting environmental standards through appropriate technology including marine, riverine and Zero Liquid Discharge (ZLD).
4. **Scheme for Incubation in Apparel Manufacturing (SIAM):** This scheme has been launched in January 2014 with initial outlay of Rs.38.8 crore for setting up three Incubation Centres @12.93 crore /Incubation Centre. The objective of the Scheme is promote new entrepreneurs in apparel manufacturing by providing them an integrated workspace with complete ecosystem and plug and play facility which help them in reducing time, cost and efforts involved in setting up a new incubation centre. These integrated workspaces and allied services would allow the entrepreneurs to execute their ideas and deliver their products through a process that is operationally and financially viable.
5. **Scheme for Textile Industry Worker's Accommodation:** The Scheme for Textile Worker's Accommodation was launched in 2014 with an outlay of Rs.45 crore for implementation during the 12th Five Year Plan. The objective of the Scheme is to provide safe, adequate and conveniently located accommodation for textile and apparel industry workers in the proximity of areas of high concentration of textile and apparel industries. Two such projects have been sanctioned in October, 2014 for, Gujarat Eco-Textiles Park Pvt. Limited in Gujarat and Palladam Hi-Tech Weaving Park Pvt. Limited in Tamilnadu and are currently under implementation.
6. **Scheme for promoting usage of Agrotexiles in North East Region:** Scheme has an outlay of Rs. 55 crore in the 12th five year plan. The aim is to encourage utilization of Agrotexiles in improving the Agriculture, horticulture and floricultural produce of the N-E states through awareness programmes, Development of Agrotextile products suitably customized for use in the North-Eastern region, Creating demonstration set-up depicting the benefit of usage of Agrotextile products suitable for the region. Further under the scheme Agrotextile-Kits will be provided to farmers

containing the Agrotextile material, instructions, right methods and practices when using Agrotextile products etc.

7. **Scheme for promoting usage of Geotechnical textiles in North East Region:** Scheme in the 12th five year plan has an outlay of Rs. 427 crore. The aim is to utilize Geotextiles in development of the infrastructure of the NE states by providing technological and financial support by meeting additionality in project cost due to the usage of Geotextiles in existing/ new project in road, hill/ slope protection and water reservoir.
8. **North East Region Textiles Promotion Scheme (NERTPS):** This scheme has been introduced for the development of various segments of textiles in North East States since 2013-14 with an outlay of Rs 1038.10 crore. The specific objectives of the scheme is to increase in the value of textile production, technology up-gradation, and improvement in design capability, diversification of product lines and value addition, better access to domestic and export markets, clusterisation and improvement in labour productivity as well as to develop and modernise the textile sector in the North East Region by providing the required Government support in terms of raw material, seed banks, machinery, common facility centres, skill development, design support etc. Special Landmark initiative has been taken by Ministry for setting up of Apparel & Garment Making Centers in all NER States.
