2135. DR. K. KAMARAJ:

Will the Minister of **AYURVEDA, YOGA AND NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY (AYUSH)** be pleased to state:

- (a) the details of Unani medical colleges, hospitals, dispensaries set up in the country during the last three years and the current year, State/UT-wise;
- (b) the details of funds allocated and utilised in regard to Unani Colleges, hospitals and dispensaries during the last three years, State/UT-wise; and
- (c) the steps being taken by the Government to increase number of such institutions and fund allocation for the Unani system?

(a) to (c) As health is a State Subject, setting up of new Unani medical colleges, hospitals and dispensaries are under the purview of concerned State/UT Governments. However, under the component of AYUSH Educational Institutions & AYUSH Services of Centrally Sponsored Scheme of National AYUSH Mission (NAM), there are provisions to set up State Government AYUSH Colleges in the State where it is not available in Government sector as well as Hospitals including Unani system. Under NAM, financial assistance has been provided for setting up of 50 bedded integrated AYUSH hospitals including Unani system. However, no financial assistance has been provided for setting up of new Unani medical colleges and dispensaries. The detail of funds released and utilized with regard to setting of 50 bedded integrated AYUSH Hospitals including Unani system during the last three years and current year State/UT-wise is furnished at **Annexure-I**.

Further, the Ministry of AYUSH has granted permission under section 13A of Indian Medicine Central Council Act, 1970 to start 05 new Unani College and attached Hospitals during the last three years. The detail is furnished at **Annexure-II**.

Under NAM an amount of Rs. 400.00 Crores has been allocated during 2016-17 for different activities of AYUSH system including Unani system of medicine. No separate system-wise allocation has been made under NAM.
