2463. SHRI BHOLA SINGH:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether many State Governments have reportedly failed to pay unpaid dues to the Khadi institutions;
- (b) if so, the details thereof and the reasons therefor, State/UT-wise; and
- (c) the details of allocation of funds made for Khadi and Village Industries Commission during the last three years in the country, State/UT-wise?

(a): Details of unpaid dues of Khadi Institutions from State Governments is not maintained in the Ministry.

(b): Does not arise.

(c): Allocation of funds to Khadi and Village Industries (KVIC) is made Scheme-wise and not State/UT-wise by the Ministry. In case of Prime Minister's Employment Generation Programme (PMEGP) Scheme for which KVIC is the nodal agency at the national level, State-wise allocation is made. Details of State/UT-wise allocation for PMEGP is at *Annexure*. Details of funds allocated (RE) (scheme-wise) to KVIC during 2013-14, 2014-15 & 2015-16 is given below:
