- (c) if so, the details thereof and the action taken thereon?

(a): The Levy Sugar Price Equalisation Fund (LSPEF) claims are submitted by the respective States to Food Corporation of India (FCI) for payment. FCI has informed that all claims received have been paid after deducting the inadmissible amount of the claim except current year. The state-wise details of the amount due and paid during the last three years and current year is enclosed at Annexure.

(b) & (c): LSPEF dues are related to period prior to de-regulation of sugar sector. State Government from time to time submit their LSPEF dues claims to FCI for payment. FCI has been advised to make prompt settlement.
