Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION उपभोक्ता मामले, खाद्य और सार्वजनिक वितरण मंत्री be pleased to state:

- (a) whether the Government has set up point of sale equipment in Fair Price Shops for the identification of beneficiaries under the scheme of automation of Fair Price Shops;
- (b) if so, the details and the current implementation status thereof, State-wise;
- (c) whether the Government proposes to provide incentives to the States that achieve cent per cent implementation of the scheme, if so, the details thereof, State-wise; and
- (d) the steps taken by the Government to achieve cent per cent coverage of the scheme?

A N S W E R MINISTER OF STATE FOR CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SHRI C. R. CHAUDHARY)

(a) to (d): This Department has prepared guidelines for Fair Price Shop (FPS) automation, which have been shared with all States/UTs. FPS automation involves, installation of Point of Sale (PoS) devices at FPS for authentication of beneficiaries, recording of sales to beneficiaries at the FPS; and uploading of transaction data in central server. As regards financial assistance, Government has approved norms for expenditure on FPS dealers' margins @ Rs. 87/qtl. under NFSA, which also includes Rs. 17/qtl. for purchase and operations of the e-PoS machines. Such expenditure is shared between Centre and State Govts. on 75:25 basis for special category States/UTs and on 50:50 basis for general category States/UTs. A State/UT wise details of operational e-POS is enclosed.
