(a) to (c) : The Price Monitoring Cell (PMC), set up in the Department of Consumer Affair is monitoring, on a daily basis, prices of 22 essential food items which includes cereals (rice and wheat), pulses (gram, arhar, urad, moong and masoor dal), vegetables (potato, onion and tomato), edible oils (groundnut, mustard, vanaspati, soya, sunflower and palm oil) & others (atta, milk, sugar, tea, gur and salt). Price trends for last three years, based on the information from reporting centres is at **Annexure.**

(d) : The price trends and availability of select essential food items are monitored on regular basis at the highest levels, including by Committee of Secretaries, Inter Ministerial Committee etc. for appropriate policy intervention.
